State Meets- State Meet dates, projected numbers, bids, fees, awards, designation dates, qualifying scores, and judge panel sizes were discussed.

Level 6,7, Plat & Diam	March 23-25, 2018
Bronze & Silver	April 6-8, 2018

•Designation Dates:

Dana made a motion that the Fall designation date for 1-5 state meet be November 15, 2017.

Anna seconded.

Motion passed unanimously.

The Spring designation date for all other state meets will remain February 22<sup>nd</sup>.

•Bids:

State Meet bids will be emailed to clubs by May 1<sup>st</sup> and will be due by May 20<sup>th</sup> so the board may vote on them by June 1<sup>st</sup>.

•Entry Fees: State Meet Entry Fees went up in the USA Gymnastics Rules and Policies.

Mark made a motion that the entry fee for Level 1-5 State Meet would be \$75 w/ a \$5 meet tax.

Ashley seconded.

7 in favor, 1 opposed and 1 abstained.

Motion passed.

Anna made a motion that Xcel levels at state meets will have a \$75 entry fee and a \$5 meet tax.

Janet seconded.  
8 in favor, 1 opposed.  
Motion passed.

Janet made a motion that Optional levels (6-10) at state meets will have an \$85 entry fee with no meet tax.

Anna seconded.  
Motion passed unanimously.

Event specialists will pay the same entry fee as other competitors in their level.

•Judge Panels:

Dana made a motion that Levels 1&2 will have 2 judge panels and Levels 3-5 will have 4 judge panels at State Meet.

Davita seconded.  
8 in favor, 1 opposed.  
Motion passed.

Stacey made a motion that Level 8-10 & Gold State Meet will have 4 judge panels.

Janet seconded.  
Motion passed unanimously.

Mark made a motion that Level 6-7, Platinum & Diamond State Meet will have 4 judge panels.

Anna seconded.  
Motion passed unanimously.

Mark made a motion that Xcel Bronze & Silver State Meet will have 2 judge panels.

Ashleyanne seconded.  
Motion passed unanimously.

•Qualifying Score:

Janet made a motion that the state meet qualifying score for Bronze will be a 32.00 AA.

Anna seconded.  
Motion passed unanimously.

All other state meet qualifying scores will remain the same as last year.

Age Group guidelines will remain the same as last year.

•Awards:

Tricha motioned that all levels will follow 50% + 1 for events and 100% placement with medals for AA at State Meets.

Ashley seconded.  
Motion passed unanimously.

The Annual Open State Meeting will take place on August 27<sup>th</sup> at 3 pm at Carolina Gymnastics Center in Columbia. At the meeting Level 3 Open and Novice Team Awards will be discussed.
